The Portsmouth Clean Community Commission recognizes that businesses are a highly visible reflection of any city and the image they portray assist in the formation of public perspective.

The Clean Business Recognition Program is a way for Portsmouth citizens to provide recognition to businesses that assist in the beautification and the cleanliness of their business community.

Clean Business Award winners will be recognized for their assistance in the beautification of Portsmouth with a sign or banner that can be placed in their store front for one month. In addition, the winning business will receive recognition on Portsmouth's Channel 48, on the city's website and in the Portsmouth Living section of *The Virginian-Pilot*.



Who is eligible...

If you or someone you know owns a business that contributes to the beautification and cleanliness of its surrounding business community and/or neighborhood, the Portsmouth Clean Community Commission would like to extend an invitation to you!

* All churches, schools and Government agencies are eligible and are encouraged to participate.

Mr. Griggs of WaysideCleaners.com is a prime example of a Clean Business Award recipient and extends a challenge to other business owners. Mr. Griggs invests heavily in beautifying his business and says, "I have made community enhancement and beautification my number one priority."

Judging

Nominees will be scored by a panel of judges selected by the Clean Community Commission. Each business will be judged based on a 100 point scale allotting points for curb appeal, general business appearance and signage. Businesses will be scored based on the following criteria:

- *Window display
- *Litter & debris control
- *Proper displaying of sign
- *Maintenance/ Physical up keep
- *Cleanliness of parking lot and business front
- *Sign maintenance
- *Landscaping

The presentation of awards and judging of businesses will take place on a quarterly basis. Winners will be selected according to their scores and the business that receives the highest score will win the Clean Business Recognition award.

How Can I sign up...

The Clean Community Commission will accept applications for nominees year round.
